§1 Description of services

The dog day care center guarantees a species-appropriate accommodation of the dog during the agreed period of stay. The dog day care center will inform the dog owner immediately if health or psychological disorders occur with his dog or if the dog shows acclimatization problems that exceed the usual level.

§2 Health/vaccinations

a) The dog owner assures that the dog has full vaccination protection against distemper, hepatitis, parvovirosis, parainfluenza (including kennel cough), leptospirosis and rabies and is free from endo- and ectoparasites. Every three months, regular proof must be provided that there is no infestation by endoparasites, in particular giardia, etc. (fecal/laboratory examination).

- ${\bf b}{\bf)}$ The dog owner assures that the dog is free of contagious diseases at the time of delivery.
- If a disease is suspected, the dog owner is obliged to explicitly point this out.
- c) The dog owner assures that the dog is not in heat at the time of delivery.

§3 Liability insurance

The dog owner assures that a valid liability insurance exists for the dog.

§4 Assumption of costs

The dog owner agrees that all efforts, without regard to cost, shall be made by a veterinarian or other third party in case of illness or accident of his dog. The dog owner assumes the costs arising from this.

§5 Liability

The dog day care center is liable to the dog owner for itself and its vicarious agents - regardless of the legal reason - only in case of intent and gross negligence as well as culpable injury to life, body and health. The dog day care center is thus not liable in cases of slight and medium negligence, unless it is a culpable breach of essential contractual obligations. In the latter case, liability is limited to the reasonably foreseeable damage typical for the contract. The above limitations of liability apply in particular to damage to the dog and in the event of loss or death of the dog. The dog day care center is not liable in particular for: Damage to the dog, Damage to the litter of bitches in heat / pregnant bitches, Damage to the birth of pregnant bitches, Mating of a bitch in heat, Damage caused by undetected contagious diseases of a dog in the dog day care center. The owner indemnifies the dog day care center from claims of third parties caused by the accommodated dog.

§6 Period of the agreement and remuneration

a) single day

The date of the individually booked day must be agreed upon in advance.

b) a collective ticket (10 or 5 tickets) with several days

The collective card is valid for the specified number of days. The collective card is valid for 6 months. The respective dates are to be coordinated in advance.

Addition to a) and b): Booked appointments that have not been cancelled by WhatsApp or SMS at least 2 working days (Monday to Friday until 2 pm, excluding public holidays and bridge days) before the booked appointment will be charged.

A refund, even partial, is not possible.

c) a time ticket (monthly ticket)

The time ticket is valid for the period indicated in each case. Time tickets are automatically extended by one month if we do not receive a written change or cancellation for the following month by the 20th of the month at the latest. Dates on which the dog does not appear will not be refunded.

By signing the contract, the dog owner agrees to pay the corresponding amount. Payment of the amount is due no later than the first time the dog is dropped off.

§7 Collection

If the dog is not picked up at the agreed time without prior agreement, the dog day care center is entitled to charge the dog owner for the resulting costs. The costs will be calculated according to time and effort.

§8 Final provisions

a) Changes, additions or extensions to the contract must be made in writing.

b) Should one or more of these provisions be or become invalid, this shall not affect the validity of the remaining provisions. The parties undertake to replace the invalid or ineffective provision with a new provision that comes as close as possible to the invalid or ineffective provision.

c) I agree with the above mentioned conditions also for subsequent stays of my dog, as long as there are no changes. However, if there are any changes, the dog owner and the dog day care center are obliged to notify each other.
